  Die Herbonauten is a herbarium specimen transcription platform addressing German speaking
  Citizen Scientists with a strong interest in botany and natural history in general.

  Only used by the Botanic Garden Berlin. There is a "sister project" Les Herbonautes in Paris who developed the software platform (in French).
- 11. Any restrictions as to who can use the platform: no
- 12. Primary language(s) supported: German
- 13. Primary volunteer base or core users of the platform: Unclear. We usually do not know our citizen scientists.
- 14. Brief description of method(s) for quality control/quality assurance available on the platform: All data are entered twice (by different persons). If they do not agree on a specific transcription, they try to resolve the problem in the forum. In addition we carried out a statistical analysis of the data quality and found that >95% of the data are correct.
